The main terms and conditions that were included in the Solid Facility Agreement are: (i) the Facility Agreement is subordinated to the Facility Agreement originally dated February 1, 2017 (as amended and/or supplemented, the "BDO Facility Agreement") signed between CHP, APO Cement Corporation, Solid and BDO Unibank, Inc., except that prepayments by Solid are allowed if proceeds are sourced from an equity fundraising activity by CHP; and (ii) the Solid Facility Agreement may only be terminated if allowed under the BDO Facility Agreement.
