("BDO") has agreed to waive CHP's compliance with the following financial covenants stated under the Facility Agreement dated 1 February 2017 (as from time to time amended, modified or supplemented) and the Facility Agreement dated 28 July 2022, during the period beginning from 31 December 2022 up to, and including, 31 December 2024: (i) a ratio of consolidated total debt to consolidated EBITDA not exceeding 4.00x; and (ii) a ratio consolidated EBITDA to consolidated interest expense not less than 4.00x. BDO's waiver is subject to the maintenance of a debt service reserve account.
