#### Dear Gentlemen:

We submit an Amended General Information Sheet of CEMEX HOLDINGS PHILIPPINES, INC. (the "Corporation") for 2022.

The amendments principally reflect a change in the board membership and appointment of principal officer. During the meeting of the Board of Directors of the Corporation held on 28 July 2022, Mr. JESÚS ORTIZ DE LA FUENTE was (i) elected as a member of the Board of Directors of CHP effective on 29 July 2022 and (ii) appointed as CHP's Vice President for Strategic Planning effective on 1 August 2022. These changes arose due to the resignation of Mr. Alejandro Garcia Cogollos as Board member and Vice President of CHP. Accordingly, page 4 and the Beneficial Ownership Declaration sheet of the 2022 General Information Sheet were amended. Furthermore, page 5 was updated to confirm the status of Ms Lacson-del Rosario as a stockholder of CHP.
