**Item 1. Security and Issuer**

This report relates to the Common shares in **CEMEX HOLDINGS PHILIPPINES, Inc** ("the Registrant")

**Item 2. Identify and Background**

- (a) The person filing this Form is GIC Private Limited ("GIC"), a private company incorporated in Singapore under the Singapore Companies Act and wholly owned by the Government of Singapore.
- (b) The business address of GIC is 168 Robinson Road #37-01 Capital Tower Singapore 068912.
- (c) GIC was set up with the sole purpose of managing Singapore's foreign reserves. Its principal place of business is at the address stated in (b) above.
- (d) During the last 5 years, GIC has not been convicted in any criminal proceeding.
- (e) During the last 5 years, GIC has not been a party to any civil proceeding of any judicial/administrative body of competent jurisdiction, domestic or foreign, resulting in GIC being subject to any order, judgment or decree, which permanently or temporarily enjoins, bars, suspends or otherwise limits its involvement in any type of business, securities, commodities or banking.

**Item 3. Purpose of Transaction**

These transactions were part of normal course of portfolio management.

**Item 4. Interest in Securities of the Issuer**

- (a) The aggregate number of common shares in the Registrant beneficially owned by GIC is 297,613,000 which represent 5.728% of the Common shares issued by the Registrant.

(b) GIC Private Limited ("GIC") is a fund manager and only has 2 clients – the Government of Singapore ("GoS") and the Monetary Authority of Singapore ("MAS"). Under the investment management agreement with GoS, GIC has been given the sole discretion to exercise the voting rights attached to, and the disposition of, any shares managed on behalf of GoS. As such, GIC has the sole power to vote and power to dispose of the 236,043,200 securities beneficially owned by it. GIC shares power to vote and dispose of 61,569,800 securities beneficially owned by it with MAS.


GIC disclaims membership in a group.

(c) On 18 July 2016, GIC acquired 293,813,000 shares through IPO subscription at PHP10.75 per share and 3,800,000 shares through on market purchases at PHP11.097 per share.


